Course Outline **Inadmissibility, Enforcement and Removals** **IMPR9102**

COURSE DESCRIPTION

This is the second course in the Immigration Practitioner Certificate Program. This course presents the grounds of inadmissibility which constitute barriers to admission to Canada for all temporary and permanent applicants. It also deals with the enforcement of immigration rules at the border and inside Canada, including the removals process for those found to be inadmissible. Learners will demonstrate an understanding of the concepts and related documentation relating to inadmissibility, enforcement and removals.

LEARNING OUTCOMES

Learners will demonstrate an understanding of the concepts and related documentation relating to inadmissibility, enforcement and removals. By the end of this course, through in-class and online activities and assessments, learners will demonstrate an understanding of the following:

- Current Canadian legal terminology applicable to Canadian Immigration Law and other relevant legislation
- The roles and responsibilities of authorized immigration representatives
- The concepts and grounds of inadmissibility
- The federal departments and agencies that have a role in immigration services
- The types of administrative tribunals
- Tribunals and jurisdiction
- Administrative agencies and tribunal processes
- The Immigration and Refugee Board
- Appeals and judicial reviews
- Inadmissibility on security grounds
- Inadmissibility on grounds of violating human or international rights
- Inadmissibility on criminal grounds
- Medical inadmissibility

- Financial inadmissibility, inadmissibility due to non-compliance with IRPA, and inadmissible family members
- Misrepresentation
- Temporary Residence Permits and Temporary Resident Permit holder class for permanent residence
- Applications for criminal rehabilitation
- Detention review procedures
- Residency requirements for permanent residents

Learners will also demonstrate an ability to undertake the following:

- Research, develop and implement a case strategy
- Complete application forms relating to inadmissibility under IRPA and IRPR
- Research relevant immigration-related websites
- Use Canadian legal terminology
- Interpret and apply statutes and regulations
- Collect, analyze and organize information
- Search relevant immigration-related websites
- Employ research methodologies to solve problems
- Collect information from clients to inform the application process
- Determine eligibility for the most appropriate programs
- Review cases and identify required documentation for application
- Review cases and present immigration options
- Prepare and present opening statements, rebuttal and closing arguments
- Develop a case strategy, including determination of admissibility
- Represent clients at tribunals
- Explain Canada's judicial system as it applies to immigration

PERFORMANCE EVALUATION

Learner progress will be assessed based on a combination of participation, attendance, assignments, quizzes and activities completed throughout the course and a multiple choice final exam. Participation, attendance, assignments, quizzes and activities will count for 50% of the course mark and the final exam will count for 50% of the course mark.
